



# COMMERCIAL VENDOR CONTRACT

**PLEASE NOTE: DUE TO A CHANGE FROM THE STATE FIRE MARSHALL ALL CONTRACTS MUST BE RECEIVED BY APRIL 1.**

THIS AGREEMENT is entered into by and between the **All American Youth Horse Show** [Show], and \_\_\_\_\_ [Vendor], for the Event, known as the All American Youth Horse Show, being held at the Ohio Exposition Center [OEC] in Columbus, Ohio, in May of this year. Exact dates are listed at the bottom of this contract.

1. Vendor will lease exhibit space in the Gilligan building from the Show for the express purpose of the retail of goods or services to the public. The Vendor's Ohio license number is: \_\_\_\_\_.
2. The Show will select and lease to the Vendor its assigned space. Vendor shall pay the sum of \$\_\_\_\_\_, for such space, the size being \_\_\_\_\_, for: inside space\_\_\_\_ outside space \_\_\_\_ [check one]
3. If Vendor will use **any** electricity, Vendor shall pay an additional fee of \$50, per requirement of the OEC. Vendor will \_\_\_ will not \_\_\_ [check one] use any electricity at this event.
4. Vendor will comply with all local, state and federal regulations, including the collection and payment to the proper governing authorities of all applicable sales tax. The current tax rate in Columbus, Ohio is 7.5%.
5. Materials used in the installation of Vendor's display must conform to the requirements of the building and inspection authorities having local jurisdiction.
6. If Vendor has a canopy or some other type of cover over its display, Vendor **shall** install a smoke detector, per State Fire Marshall.
7. All electrical and extension cords must have a 3-wire grounded plug and be appropriately covered to prevent trip and falls.
8. Propane and flammable products are prohibited in the exhibit area.
9. Vendor shall procure and maintain insurance against claims for injury, death, damage, or any other loss arising from or claimed to have arisen from Vendor's occupancy or operations at the OEC.
10. Vendor shall have access to its assigned space from 6:00 a.m., Wed., through 9:00 p.m., Sun. of the show week. **Any Vendor moving in prior to 6:00 a.m. on Wednesday shall be fined \$1,000, payable to the OEC.**
11. The Show shall not be responsible for any loss, damage, injury, death, theft or disappearance which may occur to Vendor, its employees, or its property from any cause whatsoever, prior, during or subsequent to the period covered by this contract, Furthermore, Vendor, upon signing this contract expressly releases the Show and its agents, board members and the OEC from, and agrees to indemnify and hold harmless the same against any and claims for loss, damage, injury or death that may arise in connection with Vendor's occupancy and activities at this event.
12. **If the Vendor wishes to be recognized in the Event's souvenir program, this contract MUST be returned by April 1 of the show year. Otherwise, this contract must be signed and returned on or before April 1 to: Keith E. Osborne, AAYHS, 20155 Florence Chapel Pike, Circleville, OH 43113. Payment for Vendor's space is due upon Vendor's arrival at this event.**
